

## National curriculum in England: mathematics programmes of study

### **Purpose of study**

Mathematics is a creative and highly interconnected discipline that has been developed over centuries, providing the solution to some of history's most intriguing problems. It is essential to everyday life, critical to science, technology and engineering, and necessary for financial literacy and most forms of employment. A high-quality mathematics education therefore provides a foundation for understanding the world, the ability to reason mathematically, an appreciation of the beauty and power of mathematics, and a sense of enjoyment and curiosity about the subject.

### **Aims**

The national curriculum for mathematics aims to ensure that all pupils:

- become fluent in the fundamentals of mathematics, including through varied and frequent practice with increasingly complex problems over time, so that pupils develop conceptual understanding and the ability to recall and apply knowledge rapidly and accurately
- reason mathematically by following a line of enquiry, conjecturing relationships and generalisations, and developing an argument, justification or proof using mathematical language
- can solve problems by applying their mathematics to a variety of routine and non-routine problems with increasing sophistication, including breaking down problems into a series of simpler steps and persevering in seeking solutions

Mathematics is an interconnected subject in which pupils need to be able to move fluently between representations of mathematical ideas. The programmes of study are, by necessity, organised into apparently distinct domains, but pupils should make rich connections across mathematical ideas to develop fluency, mathematical reasoning and competence in solving increasingly sophisticated problems. They should also apply their mathematical knowledge to science and other subjects.

The expectation is that the majority of pupils will move through the programmes of study at broadly the same pace. However, decisions about when to progress should always be based on the security of pupils' understanding and their readiness to progress to the next stage. Pupils who grasp concepts rapidly should be challenged through being offered rich and sophisticated problems before any acceleration through new content. Those who are not sufficiently fluent with earlier material should consolidate their understanding, including through additional practice, before moving on.

### **Information and communication technology (ICT)**

Calculators should not be used as a substitute for good written and mental arithmetic. They should therefore only be introduced near the end of key stage 2 to support pupils' conceptual understanding and exploration of more complex number problems, if written and mental arithmetic are secure. In both primary and secondary schools, teachers should use their judgement about when ICT tools should be used.

## **National curriculum in England: mathematics programmes of study**

### **Spoken language**

The national curriculum for mathematics reflects the importance of spoken language in pupils' development across the whole curriculum – cognitively, socially and linguistically. The quality and variety of language that pupils hear and speak are key factors in developing their mathematical vocabulary and presenting a mathematical justification, argument or proof. They must be assisted in making their thinking clear to themselves as well as others, and teachers should ensure that pupils build secure foundations by using discussion to probe and remedy their misconceptions.

### **School curriculum**

The programmes of study for mathematics are set out year-by-year for key stages 1 and 2. Schools are, however, only required to teach the relevant programme of study by the end of the key stage. Within each key stage, schools therefore have the flexibility to introduce content earlier or later than set out in the programme of study. In addition, schools can introduce key stage content during an earlier key stage, if appropriate. All schools are also required to set out their school curriculum for mathematics on a year-by-year basis and make this information available online.

### **Attainment targets**

By the end of each key stage, pupils are expected to know, apply and understand the matters, skills and processes specified in the relevant programme of study.

### **Key stage 1 - years 1 and 2**

The principal focus of mathematics teaching in key stage 1 is to ensure that pupils develop confidence and mental fluency with whole numbers, counting and place value. This should involve working with numerals, words and the 4 operations, including with practical resources [for example, concrete objects and measuring tools].

At this stage, pupils should develop their ability to recognise, describe, draw, compare and sort different shapes and use the related vocabulary. Teaching should also involve using a range of measures to describe and compare different quantities such as length, mass, capacity/volume, time and money.

By the end of year 2, pupils should know the number bonds to 20 and be precise in using and understanding place value. An emphasis on practice at this early stage will aid fluency.

Pupils should read and spell mathematical vocabulary, at a level consistent with their increasing word reading and spelling knowledge at key stage 1.

### Year 1

Unit	Knowledge & Skills
<b>Number and place value</b>	<p><b>Statutory</b> Pupils should be taught to:</p> <ul style="list-style-type: none"> <li>• count to and across 100, forwards and backwards, beginning with 0 or 1, or from any given number</li> <li>• count, read and write numbers to 100 in numerals; count in multiples of 2s, 5s and 10s</li> <li>• given a number, identify 1 more and 1 less</li> <li>• identify and represent numbers using objects and pictorial representations including the number line, and use the language of: equal to, more than, less than (fewer), most, least</li> <li>• read and write numbers from 1 to 20 in numerals and words</li> </ul>
	<p><b>Notes and guidance (non-statutory)</b></p> <ul style="list-style-type: none"> <li>• Pupils practise counting (1, 2, 3...), ordering (for example, first, second, third...), and to indicate a quantity (for example, 3 apples, 2 centimetres), including solving simple concrete problems, until they are fluent.</li> <li>• Pupils begin to recognise place value in numbers beyond 20 by reading, writing, counting and comparing numbers up to 100, supported by objects and pictorial representations.</li> <li>• They practise counting as reciting numbers and counting as enumerating objects, and counting in 2s, 5s and 10s from different multiples to develop their recognition of patterns in the number system (for example, odd and even numbers), including varied and frequent practice through increasingly complex questions.</li> <li>• They recognise and create repeating patterns with objects and with shapes.</li> </ul>
<b>Number - addition and subtraction</b>	<p><b>Statutory</b> Pupils should be taught to:</p> <ul style="list-style-type: none"> <li>• read, write and interpret mathematical statements involving addition (+), subtraction (–) and equals (=) signs</li> <li>• represent and use number bonds and related subtraction facts within 20</li> <li>• add and subtract one-digit and two-digit numbers to 20, including 0</li> <li>• solve one-step problems that involve addition and subtraction, using concrete objects and pictorial representations, and missing number problems such as <math>7 = ? - 9</math></li> </ul>
	<p><b>Notes and Guidance (non-statutory)</b> Pupils memorise and reason with number bonds to 10 and 20 in several forms (for example, <math>9 + 7 = 16</math>; <math>16 - 7 = 9</math>; <math>7 = 16 - 9</math>). They should realise the effect of adding or subtracting 0. This establishes addition and subtraction as related operations.</p> <p>Pupils combine and increase numbers, counting forwards and backwards. They discuss and solve problems in familiar practical contexts, including using quantities. Problems should include the terms: put together, add, altogether, total, take away, distance between, difference between, more than and less than, so that pupils develop the concept of addition and subtraction and are enabled to use these operations flexibly.</p>

<b>Number - multiplication and division</b>	<p><b>Statutory</b> Pupils should be taught to:</p> <ul style="list-style-type: none"> <li>• solve one-step problems involving multiplication and division, by calculating the answer using concrete objects, pictorial representations and arrays with the support of the teacher</li> </ul>
	<p><b>Notes and guidance (non-statutory)</b> Through grouping and sharing small quantities, pupils begin to understand:</p> <ul style="list-style-type: none"> <li>• multiplication and division</li> <li>• doubling numbers and quantities</li> <li>• finding simple fractions of objects, numbers and quantities</li> <li>• They make connections between arrays, number patterns, and counting in 2s, 5s and 10s.</li> </ul>
<b>Number - fractions</b>	<p><b>Statutory</b> Pupils should be taught to:</p> <ul style="list-style-type: none"> <li>• recognise, find and name a half as 1 of 2 equal parts of an object, shape or quantity</li> <li>• recognise, find and name a quarter as 1 of 4 equal parts of an object, shape or quantity</li> </ul>
	<p><b>Notes and guidance (non-statutory)</b> Pupils are taught half and quarter as 'fractions of' discrete and continuous quantities by solving problems using shapes, objects and quantities. For example, they could recognise and find half a length, quantity, set of objects or shape. Pupils connect halves and quarters to the equal sharing and grouping of sets of objects and to measures, as well as recognising and combining halves and quarters as parts of a whole.</p>
<b>Measurement</b>	<p><b>Statutory</b> Pupils should be taught to:</p> <ul style="list-style-type: none"> <li>• compare, describe and solve practical problems for:             <ul style="list-style-type: none"> <li>○ lengths and heights [for example, long/short, longer/shorter, tall/short, double/half]</li> <li>○ mass/weight [for example, heavy/light, heavier than, lighter than]</li> <li>○ capacity and volume [for example, full/empty, more than, less than, half, half full, quarter]</li> <li>○ time [for example, quicker, slower, earlier, later]</li> </ul> </li> <li>• measure and begin to record the following:             <ul style="list-style-type: none"> <li>○ lengths and heights</li> <li>○ mass/weight</li> <li>○ capacity and volume</li> <li>○ time (hours, minutes, seconds)</li> <li>○ recognise and know the value of different denominations of coins and notes</li> <li>○ sequence events in chronological order using language [for example, before and after, next, first, today, yesterday, tomorrow, morning, afternoon and evening]</li> </ul> </li> <li>• recognise and use language relating to dates, including days of the week, weeks, months and years</li> <li>• tell the time to the hour and half past the hour and draw the hands on a clock face to show these times</li> </ul>

	<p><b>Notes and guidance (non-statutory)</b></p> <ul style="list-style-type: none"> <li>• The pairs of terms: mass and weight, volume and capacity, are used interchangeably at this stage.</li> <li>• Pupils move from using and comparing different types of quantities and measures using non-standard units, including discrete (for example, counting) and continuous (for example, liquid) measurement, to using manageable common standard units.</li> <li>• In order to become familiar with standard measures, pupils begin to use measuring tools such as a ruler, weighing scales and containers.</li> <li>• Pupils use the language of time, including telling the time throughout the day, first using o'clock and then half past.</li> </ul>
<p><b>Geometry - properties of shapes</b></p>	<p><b>Statutory</b> Pupils should be taught to:</p> <ul style="list-style-type: none"> <li>• recognise and name common 2-D and 3-D shapes, including:             <ul style="list-style-type: none"> <li>○ 2-D shapes [for example, rectangles (including squares), circles and triangles]</li> <li>○ 3-D shapes [for example, cuboids (including cubes), pyramids and spheres]</li> </ul> </li> </ul>
	<p><b>Notes and guidance (non-statutory)</b> Pupils handle common 2-D and 3-D shapes, naming these and related everyday objects fluently. They recognise these shapes in different orientations and sizes, and know that rectangles, triangles, cuboids and pyramids are not always similar to each other.</p>
<p><b>Geometry - position and direction</b></p>	<p><b>Statutory</b> Pupils should be taught to:</p> <ul style="list-style-type: none"> <li>• describe position, direction and movement, including whole, half, quarter and three-quarter turns</li> </ul>
	<p><b>Notes and guidance (non-statutory)</b> Pupils use the language of position, direction and motion, including: left and right, top, middle and bottom, on top of, in front of, above, between, around, near, close and far, up and down, forwards and backwards, inside and outside.</p> <p>Pupils make whole, half, quarter and three-quarter turns in both directions and connect turning clockwise with movement on a clock face.</p>

### Year 2

Unit	Knowledge & Skills
<b>Number - number and place value</b>	<p><b>Statutory</b> Pupils should be taught to:</p> <ul style="list-style-type: none"> <li>• count in steps of 2, 3, and 5 from 0, and in 10s from any number, forward and backward</li> <li>• recognise the place value of each digit in a two-digit number (10s, 1s)</li> <li>• identify, represent and estimate numbers using different representations, including the number line</li> <li>• compare and order numbers from 0 up to 100; use <math>&lt;</math>, <math>&gt;</math> and <math>=</math> signs</li> <li>• read and write numbers to at least 100 in numerals and in words</li> <li>• use place value and number facts to solve problems</li> </ul> <p><b>Notes and guidance (non-statutory)</b> Using materials and a range of representations, pupils practise counting, reading, writing and comparing numbers to at least 100 and solving a variety of related problems to develop fluency. They count in multiples of 3 to support their later understanding of a third.</p> <p>As they become more confident with numbers up to 100, pupils are introduced to larger numbers to develop further their recognition of patterns within the number system and represent them in different ways, including spatial representations.</p> <p>Pupils should partition numbers in different ways (for example, <math>23 = 20 + 3</math> and <math>23 = 10 + 13</math>) to support subtraction. They become fluent and apply their knowledge of numbers to reason with, discuss and solve problems that emphasise the value of each digit in two-digit numbers. They begin to understand 0 as a place holder.</p>
<b>Number - addition and subtraction</b>	<p><b>Statutory</b> Pupils should be taught to:</p> <ul style="list-style-type: none"> <li>• solve problems with addition and subtraction:             <ul style="list-style-type: none"> <li>○ using concrete objects and pictorial representations, including those involving numbers, quantities and measures</li> <li>○ applying their increasing knowledge of mental and written methods</li> </ul> </li> <li>• recall and use addition and subtraction facts to 20 fluently, and derive and use related facts up to 100</li> <li>• add and subtract numbers using concrete objects, pictorial representations, and mentally, including:             <ul style="list-style-type: none"> <li>○ a two-digit number and 1s</li> <li>○ a two-digit number and 10s</li> <li>○ 2 two-digit numbers</li> <li>○ adding 3 one-digit numbers</li> </ul> </li> <li>• show that addition of 2 numbers can be done in any order (commutative) and subtraction of 1 number from another cannot</li> <li>• recognise and use the inverse relationship between addition and subtraction and use this to check calculations and solve missing number problems</li> </ul>

	<p><b>Notes and Guidance (non-statutory)</b>  Pupils extend their understanding of the language of addition and subtraction to include sum and difference.  Pupils practise addition and subtraction to 20 to become increasingly fluent in deriving facts such as using <math>3 + 7 = 10</math>; <math>10 - 7 = 3</math> and <math>7 = 10 - 3</math> to calculate <math>30 + 70 = 100</math>; <math>100 - 70 = 30</math> and <math>70 = 100 - 30</math>. They check their calculations, including by adding to check subtraction and adding numbers in a different order to check addition (for example, <math>5 + 2 + 1 = 1 + 5 + 2 = 1 + 2 + 5</math>). This establishes commutativity and associativity of addition.</p> <p>Recording addition and subtraction in columns supports place value and prepares for formal written methods with larger numbers.</p>
<p><b>Number - multiplication and division</b></p>	<p><b>Statutory</b>  Pupils should be taught to:</p> <ul style="list-style-type: none"> <li>• recall and use multiplication and division facts for the 2, 5 and 10 multiplication tables, including recognising odd and even numbers</li> <li>• calculate mathematical statements for multiplication and division within the multiplication tables and write them using the multiplication (<math>\times</math>), division (<math>\div</math>) and equals (<math>=</math>) signs</li> <li>• show that multiplication of 2 numbers can be done in any order (commutative) and division of 1 number by another cannot</li> <li>• solve problems involving multiplication and division, using materials, arrays, repeated addition, mental methods, and multiplication and division facts, including problems in contexts</li> </ul> <p><b>Notes and guidance (non-statutory)</b>  Pupils use a variety of language to describe multiplication and division.</p> <p>Pupils are introduced to the multiplication tables. They practise to become fluent in the 2, 5 and 10 multiplication tables and connect them to each other. They connect the 10 multiplication table to place value, and the 5 multiplication table to the divisions on the clock face. They begin to use other multiplication tables and recall multiplication facts, including using related division facts to perform written and mental calculations.</p> <p>Pupils work with a range of materials and contexts in which multiplication and division relate to grouping and sharing discrete and continuous quantities, to arrays and to repeated addition. They begin to relate these to fractions and measures (for example, <math>40 \div 2 = 20</math>, 20 is a half of 40). They use commutativity and inverse relations to develop multiplicative reasoning (for example, <math>4 \times 5 = 20</math> and <math>20 \div 5 = 4</math>).</p>
<p><b>Number - fractions</b></p>	<p><b>Statutory</b>  Pupils should be taught to:</p> <ul style="list-style-type: none"> <li>• recognise, find, name and write fractions <math>\frac{1}{3}</math>, <math>\frac{1}{4}</math>, <math>\frac{2}{4}</math> and <math>\frac{3}{4}</math> of a length, shape, set of objects or quantity.</li> <li>• write simple fractions, for example <math>\frac{1}{2}</math> of <math>6 = 3</math> and recognise the equivalence of <math>\frac{2}{4}</math> and <math>\frac{1}{2}</math>.</li> </ul> <p><b>Notes and guidance (non-statutory)</b>  Pupils use fractions as ‘fractions of’ discrete and continuous quantities by solving problems using shapes, objects and quantities. They connect unit fractions to equal sharing and grouping, to numbers when they can be calculated, and to measures, finding fractions of lengths, quantities, sets of objects or shapes. They meet <math>\frac{3}{4}</math> as the first example of a non-unit fraction.</p> <p>Pupils should count in fractions up to 10, starting from any number and using the <math>\frac{1}{2}</math> and <math>\frac{2}{4}</math> equivalence on the number line (for example, <math>1 \frac{1}{4}</math>, <math>1 \frac{2}{4}</math> (or <math>1 \frac{1}{2}</math>), <math>1 \frac{3}{4}</math>, 2). This reinforces the concept of fractions as numbers and that they can add up to more than 1.</p>

<b>Measurement</b>	<p><b>Statutory</b> Pupils should be taught to:</p> <ul style="list-style-type: none"> <li>• choose and use appropriate standard units to estimate and measure length/height in any direction (m/cm); mass (kg/g); temperature (°C); capacity (litres/ml) to the nearest appropriate unit, using rulers, scales, thermometers and measuring vessels</li> <li>• compare and order lengths, mass, volume/capacity and record the results using <math>&gt;</math>, <math>&lt;</math> and <math>=</math></li> <li>• recognise and use symbols for pounds (£) and pence (p); combine amounts to make a particular value</li> <li>• find different combinations of coins that equal the same amounts of money</li> <li>• solve simple problems in a practical context involving addition and subtraction of money of the same unit, including giving change</li> <li>• compare and sequence intervals of time</li> <li>• tell and write the time to five minutes, including quarter past/to the hour and draw the hands on a clock face to show these times</li> <li>• know the number of minutes in an hour and the number of hours in a day</li> </ul>
	<p><b>Notes and guidance (non-statutory)</b></p> <ul style="list-style-type: none"> <li>• Pupils use standard units of measurement with increasing accuracy, using their knowledge of the number system. They use the appropriate language and record using standard abbreviations.</li> <li>• Comparing measures includes simple multiples such as ‘half as high’; ‘twice as wide’.</li> <li>• Pupils become fluent in telling the time on analogue clocks and recording it.</li> <li>• They become fluent in counting and recognising coins. They read and say amounts of money confidently and use the symbols £ and p accurately, recording pounds and pence separately.</li> </ul>
<b>Geometry - properties of shapes</b>	<p><b>Statutory</b> Pupils should be taught to:</p> <ul style="list-style-type: none"> <li>• identify and describe the properties of 2-D shapes, including the number of sides, and line symmetry in a vertical line</li> <li>• identify and describe the properties of 3-D shapes, including the number of edges, vertices and faces</li> <li>• identify 2-D shapes on the surface of 3-D shapes, [for example, a circle on a cylinder and a triangle on a pyramid]</li> <li>• compare and sort common 2-D and 3-D shapes and everyday objects</li> </ul>
	<p><b>Notes and guidance (non-statutory)</b></p> <p>Pupils handle and name a wide variety of common 2-D and 3-D shapes including: quadrilaterals and polygons and cuboids, prisms and cones, and identify the properties of each shape (for example, number of sides, number of faces). Pupils identify, compare and sort shapes on the basis of their properties and use vocabulary precisely, such as sides, edges, vertices and faces.</p> <p>Pupils read and write names for shapes that are appropriate for their word reading and spelling. Pupils draw lines and shapes using a straight edge.</p>
<b>Geometry - position and direction</b>	<p><b>Statutory</b> Pupils should be taught to:</p> <ul style="list-style-type: none"> <li>• order and arrange combinations of mathematical objects in patterns and sequences</li> <li>• use mathematical vocabulary to describe position, direction and movement, including movement in a straight line and distinguishing between rotation as a turn and in terms of right angles for quarter, half and three-quarter turns (clockwise and anti-clockwise)</li> </ul>

	<p><b>Notes and guidance (non-statutory)</b>  Pupils should work with patterns of shapes, including those in different orientations.  Pupils use the concept and language of angles to describe 'turn' by applying rotations, including in practical contexts (for example, pupils themselves moving in turns, giving instructions to other pupils to do so, and programming robots using instructions given in right angles).</p>
<b>Statistics</b>	<p><b>Statutory</b>  Pupils should be taught to:</p> <ul style="list-style-type: none"> <li>• interpret and construct simple pictograms, tally charts, block diagrams and tables</li> <li>• ask and answer simple questions by counting the number of objects in each category and sorting the categories by quantity</li> <li>• ask-and-answer questions about totalling and comparing categorical data</li> </ul>
	<p><b>Notes and guidance (non-statutory)</b>  Pupils record, interpret, collate, organise and compare information (for example, using many-to-one correspondence in pictograms with simple ratios 2, 5,10).</p>

### **Lower key stage 2 - years 3 and 4**

The principal focus of mathematics teaching in lower key stage 2 is to ensure that pupils become increasingly fluent with whole numbers and the 4 operations, including number facts and the concept of place value. This should ensure that pupils develop efficient written and mental methods and perform calculations accurately with increasingly large whole numbers.

At this stage, pupils should develop their ability to solve a range of problems, including with simple fractions and decimal place value. Teaching should also ensure that pupils draw with increasing accuracy and develop mathematical reasoning so they can analyse shapes and their properties, and confidently describe the relationships between them. It should ensure that they can use measuring instruments with accuracy and make connections between measure and number.

By the end of year 4, pupils should have memorised their multiplication tables up to and including the 12 multiplication table and show precision and fluency in their work.

Pupils should read and spell mathematical vocabulary correctly and confidently, using their growing word-reading knowledge and their knowledge of spelling.

### Year 3

Unit	Knowledge & Skills
<b>Number - number and place value</b>	<p><b>Statutory</b> Pupils should be taught to:</p> <ul style="list-style-type: none"> <li>• count from 0 in multiples of 4, 8, 50 and 100; find 10 or 100 more or less than a given number</li> <li>• recognise the place value of each digit in a 3-digit number (100s, 10s, 1s)</li> <li>• compare and order numbers up to 1,000</li> <li>• identify, represent and estimate numbers using different representations</li> <li>• read and write numbers up to 1,000 in numerals and in words</li> <li>• solve number problems and practical problems involving these ideas</li> </ul>
	<p><b>Notes and guidance (non-statutory)</b> Pupils now use multiples of 2, 3, 4, 5, 8, 10, 50 and 100.</p> <p>They use larger numbers to at least 1,000, applying partitioning related to place value using varied and increasingly complex problems, building on work in year 2 (for example, <math>146 = 100 + 40 + 6</math>, <math>146 = 130 + 16</math>).</p> <p>Using a variety of representations, including those related to measure, pupils continue to count in 1s, 10s and 100s, so that they become fluent in the order and place value of numbers to 1,000.</p>
<b>Number - addition and subtraction</b>	<p><b>Statutory</b> Pupils should be taught to:</p> <ul style="list-style-type: none"> <li>• add and subtract numbers mentally, including:               <ul style="list-style-type: none"> <li>○ a three-digit number and 1s</li> <li>○ a three-digit number and 10s</li> <li>○ a three-digit number and 100s</li> </ul> </li> <li>• add and subtract numbers with up to 3 digits, using formal written methods of columnar addition and subtraction</li> <li>• estimate the answer to a calculation and use inverse operations to check answers</li> <li>• solve problems, including missing number problems, using number facts, place value, and more complex addition and subtraction</li> </ul>
	<p><b>Notes and Guidance (non-statutory)</b> Pupils practise solving varied addition and subtraction questions. For mental calculations with two-digit numbers, the answers could exceed 100.</p> <p>Pupils use their understanding of place value and partitioning, and practise using columnar addition and subtraction with increasingly large numbers up to 3 digits to become fluent</p>

<b>Number - multiplication and division</b>	<p><b>Statutory</b> Pupils should be taught to:</p> <ul style="list-style-type: none"> <li>recall and use multiplication and division facts for the 3, 4 and 8 multiplication tables</li> <li>write and calculate mathematical statements for multiplication and division using the multiplication tables that they know, including for two-digit numbers times one-digit numbers, using mental and progressing to formal written methods</li> <li>solve problems, including missing number problems, involving multiplication and division, including positive integer scaling problems and correspondence problems in which <math>n</math> objects are connected to <math>m</math> objects</li> </ul>

Pupils use factors and multiples to recognise equivalent fractions and simplify where appropriate (for example, <math>\frac{6}{9} = \frac{2}{3}</math> or <math>\frac{1}{4} = \frac{2}{8}</math> ).</p> <p>Pupils continue to practise adding and subtracting fractions with the same denominator, to become fluent through a variety of increasingly complex problems beyond one whole.</p> <p>Pupils are taught throughout that decimals and fractions are different ways of expressing numbers and proportions.</p> <p>Pupils' understanding of the number system and decimal place value is extended at this stage to tenths and then hundredths. ### Upper key stage 2 - years 5 and 6

The principal focus of mathematics teaching in upper key stage 2 is to ensure that pupils extend their understanding of the number system and place value to include larger integers. This should develop the connections that pupils make between multiplication and division with fractions, decimals, percentages and ratio.

At this stage, pupils should develop their ability to solve a wider range of problems, including increasingly complex properties of numbers and arithmetic, and problems demanding efficient written and mental methods of calculation. With this foundation in arithmetic, pupils are introduced to the language of algebra as a means for solving a variety of problems. Teaching in geometry and measures should consolidate and extend knowledge developed in number. Teaching should also ensure that pupils classify shapes with increasingly complex geometric properties and that they learn the vocabulary they need to describe them.

By the end of year 6, pupils should be fluent in written methods for all 4 operations, including long multiplication and division, and in working with fractions, decimals and percentages.

Pupils should read, spell and pronounce mathematical vocabulary correctly.

They extend their understanding of adding and subtracting fractions to calculations that exceed 1 as a mixed number.</li> <li>• Pupils continue to practise counting forwards and backwards in simple fractions.</li> <li>• Pupils continue to develop their understanding of fractions as numbers, measures and operators by finding fractions of numbers and quantities.</li> <li>• Pupils extend counting from year 4, using decimals and fractions including bridging 0, for example on a number line.</li> <li>• Pupils say, read and write decimal fractions and related tenths, hundredths and thousandths accurately and are confident in checking the reasonableness of their answers to problems.</li> <li>• They mentally add and subtract tenths, and one-digit whole numbers and tenths.</li> <li>• They practise adding and subtracting decimals, including a mix of whole numbers and decimals, decimals with different numbers of decimal places, and complements of 1 (for example, <math>0.83 + 0.17 = 1</math>).</li> <li>• Pupils should go beyond the measurement and money models of decimals, for example, by solving puzzles involving decimals.</li> <li>• Pupils should make connections between percentages, fractions and decimals (for example, 100% represents a whole quantity and 1% is <math>1/100</math> , 50% is <math>50/100</math> , 25% is <math>25/100</math> ) and relate this to finding ‘fractions of’.</li> </ul>

<b>Measurement</b>	<p><b>Statutory</b></p> <p>Pupils should be taught to:</p> <ul style="list-style-type: none"> <li>• convert between different units of metric measure [for example, kilometre and metre; centimetre and metre; centimetre and millimetre; gram and kilogram; litre and millilitre]</li> <li>• understand and use approximate equivalences between metric units and common imperial units such as inches, pounds and pints</li> <li>• measure and calculate the perimeter of composite rectilinear shapes in centimetres and metres</li> <li>• calculate and compare the area of rectangles (including squares), including using standard units, square centimetres (cm<sup>2</sup>) and square metres (m<sup>2</sup>), and estimate the area of irregular shapes</li> <li>• estimate volume [for example, using 1 cm<sup>3</sup> blocks to build cuboids (including cubes)] and capacity [for example, using water]</li> <li>• solve problems involving converting between units of time</li> <li>• use all four operations to solve problems involving measure [for example, length, mass, volume, money] using decimal notation, including scaling</li> </ul>
	<p><b>Notes and guidance (non-statutory)</b></p> <ul style="list-style-type: none"> <li>• Pupils use their knowledge of place value and multiplication and division to convert between standard units.</li> <li>• Pupils calculate the perimeter of rectangles and related composite shapes, including using the relations of perimeter or area to find unknown lengths. Missing measures questions such as these can be expressed algebraically, for example <math>4 + 2b = 20</math> for a rectangle of sides 2 cm and b cm and perimeter of 20cm.</li> <li>• Pupils calculate the area from scale drawings using given measurements.</li> <li>• Pupils use all 4 operations in problems involving time and money, including conversions (for example, days to weeks, expressing the answer as weeks and days).</li> </ul>
<b>Geometry - properties of shapes</b>	<p><b>Statutory</b></p> <p>Pupils should be taught to:</p> <ul style="list-style-type: none"> <li>• identify 3-D shapes, including cubes and other cuboids, from 2-D representations</li> <li>• know angles are measured in degrees: estimate and compare acute, obtuse and reflex angles</li> <li>• draw given angles, and measure them in degrees (°)</li> <li>• identify: <ul style="list-style-type: none"> <li>• angles at a point and 1 whole turn (total 360°)</li> <li>• angles at a point on a straight line and half a turn (total 180°)</li> <li>• other multiples of 90°</li> </ul> </li> <li>• use the properties of rectangles to deduce related facts and find missing lengths and angles</li> <li>• distinguish between regular and irregular polygons based on reasoning about equal sides and angles</li> </ul>
	<p><b>Notes and guidance (non-statutory)</b></p> <ul style="list-style-type: none"> <li>• Pupils become accurate in drawing lines with a ruler to the nearest millimetre, and measuring with a protractor. They use conventional markings for parallel lines and right angles.</li> <li>• Pupils use the term diagonal and make conjectures about the angles formed between sides, and between diagonals and parallel sides, and other properties of quadrilaterals, for example using dynamic geometry ICT tools.</li> <li>• Pupils use angle sum facts and other properties to make deductions about missing angles and relate these to missing number problems.</li> </ul>

<b>Geometry - position and direction</b>	<b>Statutory</b> Pupils should be taught to: <ul style="list-style-type: none"><li>• identify, describe and represent the position of a shape following a reflection or translation, using the appropriate language, and know that the shape has not changed</li></ul>
	<b>Notes and guidance (non-statutory)</b> Pupils recognise and use reflection and translation in a variety of diagrams, including continuing to use a 2-D grid and coordinates in the first quadrant. Reflection should be in lines that are parallel to the axes.
<b>Statistics</b>	<b>Statutory</b> Pupils should be taught to: <ul style="list-style-type: none"><li>• solve comparison, sum and difference problems using information presented in a line graph</li><li>• complete, read and interpret information in tables, including timetables</li></ul>
	<b>Notes and guidance (non-statutory)</b> <ul style="list-style-type: none"><li>• Pupils connect their work on coordinates and scales to their interpretation of time graphs.</li><li>• They begin to decide which representations of data are most appropriate and why.</li></ul>

<b>Number - addition, subtraction, multiplication and division</b>	<p><b>Statutory</b> Pupils should be taught to:</p> <ul style="list-style-type: none"> <li>• multiply multi-digit numbers up to 4 digits by a two-digit whole number using the formal written method of long multiplication</li> <li>• divide numbers up to 4 digits by a two-digit whole number using the formal written method of long division, and interpret remainders as whole number remainders, fractions, or by rounding, as appropriate for the context</li> <li>• divide numbers up to 4 digits by a two-digit number using the formal written method of short division where appropriate, interpreting remainders according to the context</li> <li>• perform mental calculations, including with mixed operations and large numbers</li> <li>• identify common factors, common multiples and prime numbers</li> <li>• use their knowledge of the order of operations to carry out calculations involving the 4 operations</li> <li>• solve addition and subtraction multi-step problems in contexts, deciding which operations and methods to use and why</li> <li>• solve problems involving addition, subtraction, multiplication and division</li> <li>• use estimation to check answers to calculations and determine, in the context of a problem, an appropriate degree of accuracy</li> </ul>
	<p><b>Notes and Guidance (non-statutory)</b> Pupils practise addition, subtraction, multiplication and division for larger numbers, using the formal written methods of columnar addition and subtraction, short and long multiplication, and short and long division (see mathematics appendix 1 (PDF, 248KB)).</p> <p>They undertake mental calculations with increasingly large numbers and more complex calculations.</p> <p>Pupils continue to use all the multiplication tables to calculate mathematical statements in order to maintain their fluency.</p> <p>Pupils round answers to a specified degree of accuracy, for example, to the nearest 10, 20, 50, etc, but not to a specified number of significant figures.</p> <p>Pupils explore the order of operations using brackets; for example, <math>2 + 1 \times 3 = 5</math> and <math>(2 + 1) \times 3 = 9</math>.</p> <p>Common factors can be related to finding equivalent fractions.</p>

### Number - Fractions (including decimals and percentages)

#### Statutory

Pupils should be taught to:

- use common factors to simplify fractions; use common multiples to express fractions in the same denomination
- compare and order fractions, including fractions  $> 1$
- add and subtract fractions with different denominators and mixed numbers, using the concept of equivalent fractions
- multiply simple pairs of proper fractions, writing the answer in its simplest form [for example,  $1/4 \times 1/2 = 1/8$  ]
- divide proper fractions by whole numbers [for example,  $1/3 \div 2 = 1/6$  ]
- associate a fraction with division and calculate decimal fraction equivalents [for example, 0.375] for a simple fraction [for example,  $3/8$  ]
- identify the value of each digit in numbers given to 3 decimal places and multiply and divide numbers by 10, 100 and 1,000 giving answers up to 3 decimal places
- multiply one-digit numbers with up to 2 decimal places by whole numbers
- use written division methods in cases where the answer has up to 2 decimal places
- solve problems which require answers to be rounded to specified degrees of accuracy
- recall and use equivalences between simple fractions, decimals and percentages, including in different contexts

#### Notes and guidance (non-statutory)

Pupils should practise, use and understand the addition and subtraction of fractions with different denominators by identifying equivalent fractions with the same denominator. They should start with fractions where the denominator of one fraction is a multiple of the other (for example,  $1/2 + 1/8 = 5/8$  ) and progress to varied and increasingly complex problems.

Pupils should use a variety of images to support their understanding of multiplication with fractions. This follows earlier work about fractions as operators (fractions of), as numbers, and as equal parts of objects, for example as parts of a rectangle.

Pupils use their understanding of the relationship between unit fractions and division to work backwards by multiplying a quantity that represents a unit fraction to find the whole quantity (for example, if quarter of a length is 36cm, then the whole length is  $36 \times 4 = 144\text{cm}$ ).

They practise calculations with simple fractions and decimal fraction equivalents to aid fluency, including listing equivalent fractions to identify fractions with common denominators.

Pupils can explore and make conjectures about converting a simple fraction to a decimal fraction (for example,  $3 \div 8 = 0.375$ ). For simple fractions with recurring decimal equivalents, pupils learn about rounding the decimal to three decimal places, or other appropriate approximations depending on the context. Pupils multiply and divide numbers with up to 2 decimal places by one-digit and two-digit whole numbers. Pupils multiply decimals by whole numbers, starting with the simplest cases, such as  $0.4 \times 2 = 0.8$ , and in practical contexts, such as measures and money.

Pupils are introduced to the division of decimal numbers by one-digit whole numbers, initially, in practical contexts involving measures and money. They recognise division calculations as the inverse of multiplication.

	<p>Pupils also develop their skills of rounding and estimating as a means of predicting and checking the order of magnitude of their answers to decimal calculations. This includes rounding answers to a specified degree of accuracy and checking the reasonableness of their answers.</p>
<p><b>Ratio and proportion</b></p>	<p><b>Statutory</b> Pupils should be taught to:</p> <ul style="list-style-type: none"> <li>• solve problems involving the relative sizes of 2 quantities where missing values can be found by using integer multiplication and division facts</li> <li>• solve problems involving the calculation of percentages [for example, of measures and such as 15% of 360] and the use of percentages for comparison</li> <li>• solve problems involving similar shapes where the scale factor is known or can be found</li> <li>• solve problems involving unequal sharing and grouping using knowledge of fractions and multiples</li> </ul>
	<p><b>Notes and guidance (non-statutory)</b> Pupils recognise proportionality in contexts when the relations between quantities are in the same ratio (for example, similar shapes and recipes).</p> <p>Pupils link percentages or <math>360^\circ</math> to calculating angles of pie charts.</p> <p>Pupils should consolidate their understanding of ratio when comparing quantities, sizes and scale drawings by solving a variety of problems. They might use the notation a:b to record their work.</p> <p>Pupils solve problems involving unequal quantities, for example, 'for every egg you need 3 spoonfuls of flour', '3/5 of the class are boys'. These problems are the foundation for later formal approaches to ratio and proportion.</p>
<p><b>Algebra</b></p>	<p><b>Statutory</b> Pupils should be taught to:</p> <ul style="list-style-type: none"> <li>• use simple formulae</li> <li>• generate and describe linear number sequences</li> <li>• express missing number problems algebraically</li> <li>• find pairs of numbers that satisfy an equation with 2 unknowns</li> <li>• enumerate possibilities of combinations of 2 variables</li> </ul>
	<p><b>Notes and guidance (non-statutory)</b> Pupils should be introduced to the use of symbols and letters to represent variables and unknowns in mathematical situations that they already understand, such as:</p> <ul style="list-style-type: none"> <li>• missing numbers, lengths, coordinates and angles</li> <li>• formulae in mathematics and science</li> <li>• equivalent expressions (for example, <math>a + b = b + a</math>)</li> <li>• generalisations of number patterns</li> <li>• number puzzles (for example, what 2 numbers can add up to)</li> </ul>

<b>Measurement</b>	<p><b>Statutory</b> Pupils should be taught to:</p> <ul style="list-style-type: none"> <li>• solve problems involving the calculation and conversion of units of measure, using decimal notation up to 3 decimal places where appropriate</li> <li>• use, read, write and convert between standard units, converting measurements of length, mass, volume and time from a smaller unit of measure to a larger unit, and vice versa, using decimal notation to up to 3 decimal places</li> <li>• convert between miles and kilometres</li> <li>• recognise that shapes with the same areas can have different perimeters and vice versa</li> <li>• recognise when it is possible to use formulae for area and volume of shapes</li> <li>• calculate the area of parallelograms and triangles</li> <li>• calculate, estimate and compare volume of cubes and cuboids using standard units, including cubic centimetres (cm<sup>3</sup>) and cubic metres (m<sup>3</sup>), and extending to other units [for example, mm<sup>3</sup> and km<sup>3</sup>]</li> </ul>
	<p><b>Notes and guidance (non-statutory)</b> Pupils connect conversion (for example, from kilometres to miles) to a graphical representation as preparation for understanding linear/proportional graphs.</p> <p>They know approximate conversions and are able to tell if an answer is sensible.</p> <p>Using the number line, pupils use, add and subtract positive and negative integers for measures such as temperature.</p> <p>They relate the area of rectangles to parallelograms and triangles, for example, by dissection, and calculate their areas, understanding and using the formulae (in words or symbols) to do this.</p> <p>Pupils could be introduced to compound units for speed, such as miles per hour, and apply their knowledge in science or other subjects as appropriate.</p>
<b>Geometry - properties of shapes</b>	<p><b>Statutory</b> Pupils should be taught to:</p> <ul style="list-style-type: none"> <li>• draw 2-D shapes using given dimensions and angles</li> <li>• recognise, describe and build simple 3-D shapes, including making nets</li> <li>• compare and classify geometric shapes based on their properties and sizes and find unknown angles in any triangles, quadrilaterals, and regular polygons</li> <li>• illustrate and name parts of circles, including radius, diameter and circumference and know that the diameter is twice the radius</li> <li>• recognise angles where they meet at a point, are on a straight line, or are vertically opposite, and find missing angles</li> </ul>
	<p><b>Notes and guidance (non-statutory)</b> Pupils draw shapes and nets accurately, using measuring tools and conventional markings and labels for lines and angles.</p> <p>Pupils describe the properties of shapes and explain how unknown angles and lengths can be derived from known measurements.</p> <p>These relationships might be expressed algebraically for example, <math>d = 2 \times r</math>; <math>a = 180 - (b + c)</math>.</p>

<b>Geometry - position and direction</b>	<p><b>Statutory</b> Pupils should be taught to:</p> <ul style="list-style-type: none"> <li>describe positions on the full coordinate grid (all 4 quadrants)</li> <li>draw and translate simple shapes on the coordinate plane, and reflect them in the axes</li> </ul>
	<p><b>Notes and guidance (non-statutory)</b> Pupils draw and label a pair of axes in all 4 quadrants with equal scaling. This extends their knowledge of one quadrant to all 4 quadrants, including the use of negative numbers.</p> <p>Pupils draw and label rectangles (including squares), parallelograms and rhombuses, specified by coordinates in the four quadrants, predicting missing coordinates using the properties of shapes. These might be expressed algebraically for example, translating vertex <math>(a, b)</math> to <math>(a - 2, b + 3)</math>; <math>(a, b)</math> and <math>(a + d, b + d)</math> being opposite vertices of a square of side <math>d</math>.</p>
<b>Statistics</b>	<p><b>Statutory</b> Pupils should be taught to:</p> <ul style="list-style-type: none"> <li>interpret and construct pie charts and line graphs and use these to solve problems</li> <li>calculate and interpret the mean as an average</li> </ul>
	<p><b>Notes and guidance (non-statutory)</b> Pupils connect their work on angles, fractions and percentages to the interpretation of pie charts.</p> <p>Pupils both encounter and draw graphs relating 2 variables, arising from their own enquiry and in other subjects.</p> <p>They should connect conversion from kilometres to miles in measurement to its graphical representation.</p> <p>Pupils know when it is appropriate to find the mean of a data set.</p>
